## 2023 Scholarship Applications now OPEN!

Dannemora FCU is proud to announce, though a partnership with the New York Credit Union Association (NYCUA), is offering high school seniors a chance to participate in two scholarship programs using a single application. The NYCUA College Scholarship Program is an exciting example of DFCU and NYCUA's "people helping people" philosophy in action.

- NYCUA Statewide Program applicants will be competing against other credit union members from across the state. Last year, NYCUA awarded \$33,750 in scholarships to 45 students through the program. The scholarships awarded ranged from \$500 to \$1,500.
- DFCU Program Enhanced for 2022/2023, DFCU is offering \$15,000 in scholarships using the same application process as the NYCUA Statewide Program. 5 students will each be awarded \$2,000 and 5 students will each be awarded \$1,000.

DFCU is happy to announce ten (10) Scholarships are available paid out in full for a new grand total of \$15,000.00 in scholarships.

Scholarships will be awarded as follows:

- 1 to 5 will receive a \$2000.00 Scholarship Award.
- o 6 to 10 will receive a \$1000.00 Scholarship Award.

"We are excited to not only increase our annual direct scholarship award from \$10,000 to \$15,000, but also to provide our members the ability to participate in the NYCUA program. #### A Tip From DFCU to YOU!

There are many unknowns for the future, but with each unknown there are proper steps to plan for them. DFCU can make sure your accounts are set up appropriately, to ensure in the event of your death, your family will not need to take any additional steps, in an already difficult time.

Stop by or call a branch, ask the representative if you have a beneficiary placed on your account. This is a very important step to take. If your account does not have a beneficiary listed when you pass away, it requires your family to go to the surrogate court to apply for the appropriate paperwork in order to access your account. This is very upsetting and frustrating for the family/friends left in charge of a persons affairs. However, when someone is listed as beneficiary on the account, the person simply needs to bring in an original death certificate, and their photo ID in order to take care of the account.

Make sure you have your affairs in order. Some info we want to leave you with today to make your life easier:

- Make sure ALL bank accounts have direct beneficiaries! The beneficiary would only need to go to the bank with a death certificate and an ID of their own.
- Have a TOD (Transfer on Death Deed). Having a TOD saves your family thousands of dollars and stress. This document
  allows you to transfer ownership to your designee.
- Make sure you have a living will. This allows you to put in writing exactly what you want done in the event you cannot speak for yourself.
- Have a Durable Power of Attorney. This allows one to designate a person to make legal decisions if you can no longer do so.
- Have a Power of Attorney for Healthcare. This document allows one to designate someone to make healthcare decisions for their person.
- Have a Last Will and Testament. Making the process easier, this document designated to whom personal belongings will go too.
